NOTICE OF NOMINATIONS AND ELECTION OF DELEGATES AND ALTERNATE DELEGATES TO THE GENERAL CONVENTION OF THE INTERNATIONAL UNION OF OPERATING ENGINEERS ("IUOE")

Sisters and Brothers:

January 8, 2018

The IUOE General Convention will commence at 9:00 o'clock am on Sunday, May 6, 2018 at the Diplomat Beach Resort Hotel in Hollywood, Florida.

In accordance with Article IV Section 3 of the IUOE Constitution, the election of IUOE General Officers, for a five (5) year term, will be conducted as the first order of business on the afternoon of the first day of the General Convention. Pursuant to Article IV Section 6 of the IUOE Constitution, the newly elected General Officers shall be installed immediately upon their election and shall assume their official duties immediately upon installation.

Pursuant to Article III Section 5 of the IUOE Constitution, Local 94-94A-94B is entitled to elect thirteen (13) delegates and two (2) alternate delegates to the IUOE General Convention.

Pursuant to Article II Section 5 of the By-Laws and General Rules of Local Union 94-94A-94B, the Business Manager, the President, the Vice President, Recording/ Corresponding

Secretary, the Financial Secretary and the Treasurer shall be designated delegates¹ to the IUOE General Convention by virtue of their office.

Pursuant to Article III Section 3 of the IUOE Constitution, a secret ballot election of eight (8) delegates and two (2) alternate delegates to the IUOE General Convention must be held in February, 2018 in accordance with the Local Union's By-Laws, as follows:

NOMINATIONS

Nominations for eight (8) delegates and two (2) alternate delegates to the IUOE General Convention will be accepted from the floor at the Local Union's special membership meeting held for that purpose at the date, time and place indicated below:

As provided in the Local 94-94A-94B By-Laws, no member shall be eligible for election, be elected nor hold office unless he/she shall have been continuously in good standing for one (1) year preceding the month of nominations, or unless within ten (10) days after having been notified in writing by the Recording /Corresponding Secretary of his/her nomination, a written acceptance of his/her nomination as a delegate is received by the Recording/Corresponding Secretary of this local union . In addition, he/she shall have been in regular attendance at all regularly scheduled Local Union membership meetings held after nominations and before

elections subject, however, to a reasonable excuse based upon good cause, such as incapacity or death in family.

Subject to the other applicable provisions of the Local Union's By-Laws, any member who has paid all of his/her dues owed through December 31, 2017 prior to 4:00pm on January 23, 2018 is in good standing and eligible to nominate candidates and to run for election as a delegate or alternate delegate.
