

## **SUMMARY ANNUAL REPORT**

### **For Annuity Fund of the I.U.O.E. Local Union 94, 94A, 94B AFL-CIO**

This is a summary of the annual report for Annuity Fund of the I.U.O.E. Local Union 94, 94A, 94B AFL-CIO, EIN 13-6817367, Plan No. 001, for period January 01, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided by a trust fund. Plan expenses were \$83,033,401. These expenses included \$2,544,309 in administrative expenses, \$79,680,510 in benefits paid to participants and beneficiaries, and \$808,582 in other expenses. A total of 7,808 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,556,652,801 as of December 31, 2020, compared to \$1,396,910,235 as of January 01, 2020. During the plan year the plan experienced an increase in its net assets of \$159,742,566. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$242,775,967, including employer contributions of \$59,865,282, rollover contributions of \$696,365, realized losses of (\$1,196,816) from the sale of assets, earnings from investments of \$182,875,134, and other income of \$536,002.
