PAC Fund is Critical in Educating and Supporting Those Who Support Our Issues

As officers and trustees of IUOE Local 94, we never forget who we are, where we came from or who we serve. Local 94 is and has been an effective representative of our 6400 members because we have always spoken with one voice — always in the best interests of our members. Much of what we have accomplished and yet need to accomplish is affected by the action of New York State and New York City elected officials and their appointed agency personnel.

To effectively promote and protect our interests in New York State and New York City government, we are asking you to join our union's political action fund.

The New York State and New York City political and legislative environment is such

that gains made by us at the bargaining table are regularly threatened by political or legislative agendas set by the business community to promote its interests at the expense of ours. I'm sure I need not remind you of the attack on the refrigeration machine operator's license. Local 94 met with several council members and aggressively and actively engaged in the political and legislative arena to thwart the legislation.

Since That Time Local 94 Has:

Participated in the review undertaken by New York City on a city-wide basis to change the FDNY Fire Code and Building Code in relation to mechanical refrigeration standards.

Conducted on-going discussions with

high ranking uniformed and civilian FDNY personnel and monitored the FDNY's plans to change the practical test for a refrigeration license.

Advocated successfully for the implementation of the Office Building Emergency Action

Plan That Went Into Effect

Met and received support from 47 NYC Council members to establish legislation which resulted in a prevailing wage for our school workers.

Hosted the New York City Commissioner of Buildings at union headquarters to demonstrate the type of professional training our members receive; to evidence our members' commitment to learn their job skills; and to showcase the new training programs instituted to ensure that our members have the skills necessary to run buildings in a safe, secure and efficient manner.

In addition, Local 94's Business Manager, Business Agents and Training Directors are regularly appointed to various New York City committees including the Administrative and Enforcement Committee, Existing Buildings Technical Committee, Fire Protection Technical Committee, Mechanical/HVAC/Boiler Technical Committee, Plumbing Technical Committee, Residential Technical Committee and the Electrical Code Committee.

While we are proud of the accomplishments we have made to date, more action is necessary.

Why do we need a political action committee? Can't Local 94 simply make political contributions from the union's general treasury?

When Local 94 supports candidates by using union operating funds out of our general treasury, Local 94 has to pay tax on those contributions. Under federal law, political contributions made by labor unions

in this manner are subject to a tax at the highest federal corporate tax rate on every dollar contributed — in effect, it costs Local 94 \$1.21 for every \$1.00 contributed to our political allies and supporters. The Union is subject to this very costly tax as not enough members support the political action fund.

Receiving the donation directly to the political action fund would only cost us a dollar to make a dollar contribution and we would not be levied with this tax.

The Local 94 political action fund will continue to operate pursuant to published by-laws and will fully comply with all New York State and New York City election laws. All contributions are fully disclosed to you at our monthly meetings and to the

public, pursuant to applicable law.

This initiative is extremely important for Local 94's continued success in our industry. On behalf of Local 94, I ask you to invest in your political and economic future by joining the political action committee.

NOTICE OF NOMINATION FOR & ELECTION OF OFFICERS OF LOCAL 94, IUOE

Dear Brother/Sister Local 94 Member:

Listed below is important information pertaining to the 2022 Nomination for and Election of Local 94 Officers.

Please read carefully

Pursuant to Article II, Section 4 of the Local 94 Bylaws, a Nominations Meeting will be held at all the General Membership Meetings on May 11, 2022.

1) Officer Positions to be elected

a) Article II Section 1 of the Local 94 Bylaws specifies the following Officer positions to be elected:

Business Manager, President, Vice President, Financial Secretary, Treasurer, Recording / Corresponding Secretary, Trustees (3), Auditors (3), Conductor, and Guard.

The Officers who are elected will serve for a term of three (3) years.

b) Pursuant to Article III, Section 5 of the Local 94 Bylaws, the Business Manager, President, Vice President, Recording/Corresponding Secretary, Financial Secretary, and Treasurer, shall be designated delegates to the IUOE Convention by virtue of their Local 94 elective office.

c) Elected officers of Local 94 may hold more than one (1) elected position concurrently.

2) Date, Time and Place of the Nominations Meetings:

a) Date: Wednesday, May 11, 2022 – General Membership Meetings

b) Time: 8:30AM – 9:30AM; 2PM-3:00PM, 5PM-6:00PM

At each meeting, nominations shall be made from the floor. All nominations must be made and be seconded by a member in good standing.

We Will Never Forget

In the event there is opposition for any Officer position, and it is necessary to have an election, a secret ballot election will be conducted by machine ballot. Listed below are the details of the election:

Date, Time and Place of Election of Officers

- a) Date: Wednesday, August 10, 2022, a secret ballot election will be conducted by machine ballot.
- b) Time: Polling hours will be from 8:00AM to 10:00PM
- c) Place: Local 94 Training Center
331 West 44th Street
New York, New York 10036 (between 8th and 9th Avenues),

The counting of the ballots will take place immediately after the polls close at 10:00PM, at the Local 94 Training Center.

To win the election, a candidate is required to receive a plurality of the votes cast; the candidate who receives the most votes wins the election.

In the event of a tie vote between any candidates, a run-off election will be held on Wednesday, August 17, 2022

3) Eligibility Requirements to Run for Office:

Pursuant to Article II, Section 2 of the Local 94 Bylaws, a member must have been in continuous good standing for a period of one (1) year preceding the month of the nominations meeting. Pursuant to Article II, Section 2 of the Local 94 Bylaws a member must accept his/her nomination in writing within ten (10) days after being notified of his/her nomination.

In addition, a candidate shall have been in regular attendance at all regularly scheduled Local Union membership meetings held after the nominations and before the elections, subject however, to a reasonable excuse based upon good cause such as incapacity or death in the family.

Article II, Section 2 of the Local 94 Bylaws, also mandates that due to the heavy responsibilities of the Business Manager, to be eligible to run for Business Manager, a member must have been in continuous good standing for a period of two (2) years preceding the month of the nominations meeting.

Any member who pays his/her dues by check off (payroll deduction), will not be denied the right to run for office or to vote in the election for reason of non-payment of dues if the member's employer has failed to deduct and/or remit the dues payments to Local 94.

Any member who is not on check off and pays his/her dues directly to Local 94 is responsible for maintaining his/her own good standing.

4) Eligibility to Vote

A member must have been in good standing on the date of the election to be eligible to vote.

Pursuant to Article VI, Section 5 of the Local 94 Bylaws, a member is in good standing if he/she has paid all dues, fines, and assessments to the Local 94 within thirty (30) days after such amounts shall become due and payable to Local 94.

5) Winners of the Election

Pursuant to Article II, Section 4 of the Local 94 Bylaws, to win the election a candidate must receive a plurality of the vote. However, in the case of the positions of Trustee and Auditor, the three (3) candidates receiving the highest number of votes for those positions shall be elected.

A Reimagined Two Bryant Park is Ready to Reemerge

When HBO left their home across from Bryant Park for Hudson Yards, the decision was made to reimagine and modernize the building which first went up in 1906. Today, after two years of renovations, Local 94 Chief Gerard Kennedy, Assistant Chief Mario Sfarlea and Engineer Charlie Cole, are in the process of commissioning the 15-story steel and glass structure.

To call the project a renovation is actually an understatement. At the very beginning all of the dark green glass cladding was removed. The building stripped down to its frame. Interior walls and even the entire second floor was removed.

Local 94 Chief Engineer Gerard Kennedy, who had been at the building for 35 years was on site for the entire project. "It's a new future project," said Kennedy. "A totally retro-fitted building."

Along with the new high lobby ceiling, and open floor plans, Kennedy, along with Assistant Chief Mario Sfarlea and Engineer Charles Cole, have been busy bringing the engine room into the 21st century.

Going for LEED Gold

Along with the new dual-temperature chillers, generators and other state-of-art systems is a large Emission Reduction Unit on the 16th floor, and solar panels on the pavilion

roof. According to Kennedy these upgrades will earn the building LEED Gold status.

Cole described the project as "a fantastic learning experience."

In keeping with the times, the care and comfort for the soon-to-arrive tenants now

goes well beyond the heat, cooling and light. In the wake of COVID-19 everyone is paying more attention to "healthy buildings."

The ERU will certainly help on that score. Those effort well go beyond engine room solutions. Like many of the new buildings going up today there is more attention to lighting, and open community space.

Once completed Bank of America will be primary tenant. It won't be long before they are in the building. According to Kennedy, construction crews are currently completing two floors every three weeks. "We expect the building to be fully occupied by the end of April," Kennedy said.

At 425 Park Avenue Focus is Centered on Comfort, Health & Wellness

Scheduled to open later this year, the steel and glass diagrid tower at the 425 Park Avenue is the latest addition to the New York skyline. Designed by Foster + Partners for L&L Holdings, teams of construction crews are currently putting the finishing touches on the 890-foot tower.

Soon to be home to Citadel Securities, as striking as the multi-tiered tower is from the outside, once inside visitors will be equally dazzled as they stand beneath the soaring 45-foot-high lobby ceiling.

Billed as the "The Healthiest Building in New York," 425 Park is the first NYC office building to be "WELL Certified" by the International WELL Building Institute.

Now however, the building is occupied by plumbers, electricians, carpenters, painters and other trades installing and adding the finishing touches needed in a Class A commercial building. Along with those tradesmen and women, are a trio of Local 94 engineers.

Led by John Fitzgibbon, Local 94 Engineers Kevin Talty and Sean Connolly are ensuring the state-of-art HVAC system, back-up generators and all other "command and control" operations are up and running – as efficiently as promised.

Fitzgibbon, a longtime Local 94 member, had previously worked as Chief Engineer at One World Trade. Now with Cushman and Wakefield, he is in the process of commissioning the building. "I guess you could call me the Mission Control Chief," Fitzgibbon explained.

State-of-the-Art Chillers

As he guides a visitor through the mechanical floors, never to be seen by the tenants or their guests, Fitzgibbon stops to extoll the wonders of the state-of-art

SMARTD chillers. "I can run these chillers with a load as low as 5%. Normally you'd be lucky to run as low as 20%. The energy savings are remarkable."

Just moments earlier Fitzgibbon was in a discussion involving an issue with the back-up generators. Later he is chatting away with a couple of electricians who are testing the breakers. "I really love being here working not only with our guys, but with everyone from the trades," Fitzgibbon confessed.

Once the building opens later this year

Fitzgibbon and his team will move on, and a fulltime Local 94 crew will take control of the building. "I expect it will be a Chief and crew of 11," said Fitzgibbon.

There will be plenty of work to keep that crew busy. In keeping with its Healthy Building promise the building will feature a rooftop "sanctuary space" with dining provided by renowned Chef David Humm, and wellness programs.

In addition to providing for the tenants, Humm will be opening Four Twenty Five, a new two-story restaurant.

Lower Manhattan Classic Gets New Address & BOMA Honor

Built as the home of US Express in 1905, the 26-story limestone tower overlooking Trinity Church still carries its original 2 Rector Street address on its eastside façade. Over the course the past century the building has undergone numerous alterations, including the addition of three stories in 1926.

Following a change of ownership in little more than six years ago, the building has undergone a sidewalk to rooftop renovation, even changing the address.

Now jointly owned by Cove Property Group and Bentall Kennedy, the building is now known as 101 Greenwich Street, and is managed by JLL. Over the course of the past two years the Beaux Arts tower has been transformed into modern office space.

Beyond the new lobby, the spacious work and meeting spaces, the massive VRF system and state-of-art efficiencies have earned the building a LEED Silver rating.

“We replaced the old pneumatic steam system with a new digital PRV system to serve the base building, providing a 18% savings,” explained Local 94 Chief James Gerardo. “Now only six floors are on the steam grid.”

Additional savings in electric, attained through a demand response program and the very efficient VRF system, helped Gerardo the Local 94 team of Assistant Chief Paul Lanton, LEED Engineer Aneil Roopnarine and Engineer Bobby Spina, 101 Greenwich

earn BOMA’s 2021 Pinnacle Award for Best Renovated Building.

For Gerardo it was his second BOMA Pinnacle Award. “We won the Small Building Award (500,000 – one million s/f) when I was working at 757 Third Avenue in



2019,” Gerardo said with pride.

In addition to the BOMA honors, Gerardo also earned JLL’s Sigma Award for Excellence. “Can you believe it two awards in three years?”

As thrilled as he is by his success, Gerardo is especially grateful for the Local 94 members who mentored and encouraged him along the way. “I wasn’t exactly the best student, and I did have some issues,” Gerardo noted.

With an assist from a friend, he was given the opportunity to work as a summer helper at 660 Madison Avenue. “Tony Costello took an interest in me, and I wanted to learn.”

Along with learning the trade, he was also being mentored by Tom Hart and veteran Local 94 members like Kevin Costello and Ralph Di Domenico. “Old school guys like Joe Dagro finished the job. They taught me not only about the work, but also about life, said Gerardo. “They molded me into to the Chief I am today.”

Today, Gerardo is not only a Local 94 Chief, he also a member of JLL’s Special Operations Team.

Led by Local 94 Team 10 Hudson Yards Sweeps BOMA Awards

As the first building to rise on the west side of Tenth Avenue 10 Hudson Yards set a high bar for the sprawling, transformational complex. In a city where all new buildings rise with great expectations, under the leadership and care of a dedicated Local 94 crew led by Chief Engineer Jon Montes, the building and the Local 94 team have exceeded all expectations.

In fact, the 57-story, 1.82M s/f glass and concrete tower – among the first fully concrete commercial buildings in New York City -- swept BOMA’s Building of the Year honors for Operating Office Building of the Year greater than 1 million s/f. with Montes named Chief Engineer of the Year.

Montes, of course, credits his Local 94 team of Assistant Chiefs Paul Mehl and Dave Velez; Lead Engineer Paul Spinale; Engineers Anthony Shahin, Michael Silecchia, Anthony Florez, Victor Pappert, Kevin Pollock; and Helpers Ronald Daniels and Angel Cruz. “We have the best operating engineers anywhere, working in this building,” Montes proudly explained.

While not taking anything away from the efforts of his top-notch crew, Montes noted that as the first building to open in the sprawling complex, it opened with several energy-saving advantages.

In fact, 10 Hudson Yards was built to LEED-NC Platinum standards.

Like a Model Home

“We were kind of like the ‘model home’ for the complex. This building went up with all the new state-of-art systems, including an on-site CoGen plant, boilers, and chiller plant,” said Montes.

Yes, it’s true the building did rise with a solid foundation for potential energy savings. However, what Montes failed to mention is that it is one thing having state-of-art technology, it’s also critically important to operate

those systems to maximum benefit.

And did they ever.

According to Montes the building has delivered some \$2 million in energy savings over the past three years.

While an impressive feat by any standard, it becomes more startling when once inside you realize you are in a building within a building. Enter from the East and you are steps away from the High Line; from the West you’ll have to pass the Vessel.

As home to international firms Tapestry (Coach, Kate Spade, Stuart Weitzman) and L’Oreal USA, Boston Consulting and SAP, there is more than enough open space and amenities to accommodate the nearly 7,000 employees.

Local 94 Women are Breaking Down Stereotypes to Heat Up Our Schools

Within the NYC Schools system the job title is listed as Fireman, yet in more and more schools across the city you will find there's a woman bringing up the heat.

It wasn't that long ago when such a career choice would have been considered as non-traditional — never mind the World War II images of Rosie the Riveter. So while those notions may die hard, they are rapidly fading away in the engine rooms of the New York City schools.





On Loan from IUOE Texas Center Virtual Welding Trainer Device is Hot Hit

According to Local 94 Training instructor Mike Kovalsky, it wasn't all that long ago when welding was an important and valuable engine room skill. "There wasn't a building without a welder, it was necessary when low pressure steam was more prevalent back in the day," said Kovalsky. "It's a still skill that is good to have, but these days most of the welding is outsourced."

A Local 94 Chief before he started teaching the ins-and-outs of Heating Pumps, Refrigeration/AC, Chillers and Electrical classes at the Training Center, Kovalsky was also a welder, picking up his skills while modifying cars for drag racing. "I was into drag racing, one day I just grabbed a piece of pipe and started welding."

As it turned out it was skill that came in handy on the job.

He was working as a chief in a midtown building when a water pipe burst open with a 1/8-inch hole. "Everyone was running around trying to figure out what to do. After we turned off the water main, I told the guys to open the hole to a half-inch. Everyone looked at me like I was crazy," Kovalsky recalled.

"Once the hole was expanded, I put in a 1/2 inch bolt and welded it to the pipe. Problem solved," said Kovalsky with a smile. "And I'll bet that weld is still holding today."

As it turned out, Kovalsky's skills were needed when IUOE Training Center in Texas, provided the Local 94 Training Center with a Vertex Mobile Welding Simulator. A pleasant surprise to Training Director Howard Styles. "We've had guys who've asked about a welding class, but there was no way




to provide the course," said Styles.

So when the simulator arrived, Kovalsky agreed to teach the course and added it to his teaching calendar.

More than a half-dozen students signed up for the 3-hour classes held over the course of five weeks. The course covered both "Stick" and "MIG" welding. According

to Kovalsky Stick welding is the most common technique which uses electrodes to create the weld. MIG refers to the use of Metal Inert Gas.

According to Kovalsky the simulator could not be any closer to the creating a real-world weld. Prior to the students arrival, Kovalsky sets up the class by opening

the device and pulling out a small video screen which he will use to monitor the students' actions. He takes out the welder's helmet and the small plastic hinge which will be used for the exercise set up some 15-20 feet away.

The exercise begins when the student puts on welding helmet, clutches the welding

tool, and begins the weld. A camera inside the helmet visor provides a "virtual" view of the metal weld, monitoring the angle, speed, and technique. All with sound effects and virtual images. As the student goes through the exercise, Kovalsky monitors every step of the exercise.

The instructor admits he can hardly

believe the vivid accuracy. "The sound changes as if you were welding metal, there's white where it's melting, the orange where it's cooling. It's as realistic as can be."

Unfortunately, there will not be any new classes on the horizon. The simulator was only sent to the local for demonstration purposes and will soon be returned to Texas.
