

SUMMARY ANNUAL REPORT

For Health & Benefit Trust Fund of the I.U.O.E. LOCAL 94, 94A, 94B, AFL-CIO

This is a summary of the annual report of the Health & Benefit Trust Fund of the I.U.O.E. LOCAL 94, 94A, 94B, AFL-CIO, EIN 13-6674743, Plan No. 501, for period January 1, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Board of Trustees Health & Benefit Trust Fund of the I.U.O.E. LOCAL 94,94A,94B, AFL-CIO has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Empire Healthchoice Assurance Inc and United Healthcare Insurance Company to pay prescription drug and stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$6,259,486.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$484,781,956 as of December 31, 2021, compared to \$427,614,366 as of January 1, 2021. During the plan year the plan experienced an increase in its net assets of \$57,167,590. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$211,460,461, including employer contributions of \$169,869,593, employee contributions of \$6,654,643, other contributions of \$46,999, realized gains of \$2,494,455 from the sale of assets, earnings from investments of \$32,330,710, and other income of \$64,061.

Plan expenses were \$154,292,871. These expenses included \$4,101,736 in administrative expenses, and \$150,191,135 in benefits paid to participants and beneficiaries.
