

SUMMARY ANNUAL REPORT

For HEALTH & BENEFIT TRUST FUND OF THE I.U.O.E. LOCAL 94, 94A, 94B, AFL-CIO

This is a summary of the annual report of the HEALTH & BENEFIT TRUST FUND OF THE I.U.O.E. LOCAL 94, 94A, 94B, AFL-CIO, EIN 13-6674743, Plan No. 501, for period January 01, 2010 through December 31, 2010. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BOARD OF TRUSTEES HEALTH & BENEFIT TRUST FUND OF I.U.O.E LOCAL 94, 94A, 94B, AFL-CIO has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has a contract with EMPIRE HEALTHCHOICE ASSUR INC. to pay stop loss and PPO claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2010 were \$758,400.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$120,378,755 as of December 31, 2010, compared to \$98,083,749 as of January 01, 2010. During the plan year the plan experienced an increase in its net assets of \$22,295,006. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$94,543,811, including employer contributions of \$86,526,942, employee contributions of \$1,838,513, other contributions of \$57,054, realized losses of (\$696,996) from the sale of assets, earnings from investments of \$6,777,370, and other income of \$40,928.

Plan expenses were \$72,248,805. These expenses included \$2,680,553 in administrative expenses, and \$69,568,252 in benefits paid to participants and beneficiaries.
