- 3. THE CONSUMPTION OF ALCOHOL OR SMOKING IS PROHIBITED IN, NEAR OR AROUND THE POOL AREA.**
- 4. ONE (1) DOOR PRIZE TICKET PER PERSON.**
- 5. EVERYONE will be required to show ID for all alcoholic beverages.**
