We have important news to share with you about your prescription drug coverage.

Effective January 1, 2026, Medicare-eligible retirees and their covered Medicare-eligible spouses and/or Medicare-eligible children will have new prescription drug coverage through Aetna Medicare Rx® offered by SilverScript® Employer PDP ("SilverScript")1.

## **Reason for the Switch**

The Fund continually looks to provide quality coverage to you and your family at the best cost available. SilverScript is a market leader in providing competitive pricing for participants who are currently enrolled in Medicare Part A and Medicare Part B.

# What SilverScript will provide

With SilverScript, you will continue to have coverage for nearly all Medicare Part D covered drugs under the Comprehensive Plus formulary. You will have access to over 63,000 national chain, regional, local and independent neighborhood pharmacies in the pharmacy network, called P1. Additionally, you can get up to a 90 days' supply at an in-network pharmacy or through the Caremark Mail Service Pharmacy.

## How this affects you and your family

On December 31, 2025, your coverage with UnitedHealthcare MedicareRx<sup>SM</sup> will terminate and, provided the Fund has the required important information set forth below, you will be automatically enrolled into the SilverScript coverage effective January 1, 2026. If your spouse or dependents are not Medicare-eligible, the Fund will continue to provide prescription drug benefits to non-Medicare-eligible participants through CVS Caremark.

Since your enrollment in SilverScript will automatically cancel your enrollment in UnitedHealthcare MedicareRx<sup>SM</sup>, you may receive a letter from UnitedHealthcare MedicareRx<sup>SM</sup> telling you that your Medicare Part D coverage is being terminated or that you are being disenrolled from that plan. **Do not worry! There will be no interruption in your prescription drug coverage**, as long as you continue to pay the required premiums for coverage.

Your SilverScript Member ID card should arrive before your effective date of January 1, 2026. Non-Medicare-eligible participants will continue using their current combined Aetna/CVS Caremark ID cards.

#### **Important Information**

in order to participate in the Local 94 Commercial Retiree benefits, you must be enrolled in both Medicare Part A and Part B so that you can also participate in the prescription coverage offered under SilverScript. If you are not currently enrolled in Medicare Parts A and B, please contact the Fund at (212) 331-1800 as soon as possible.
